223 for the United States, 1172 for China but only 126 for the EU countries. These are the numbers of unicorns (start-ups whose valuation is greater than a billion dollars and which are not listed on the stock exchange) for large economic zones and there is no doubt about a difficult reality: the European Union is lagging behind in new technologies compared to Washington and Beijing. Even if it is difficult to completely make up for this gap, it is not impossible to reduce it and have the capacity to compete with the other great powers of this world but for this, we need a European start-up policy.
